GENERAL DISPLAY CONDITIONS

1. Organizer

The fair event is organized by the company DMK Vall 042 d.o.o., I. Cankara 9a, 42000 Varaždin, Croatia.

2. The right to participate

Production, trading and service companies, public institutions, tourist organizations, crafts and family farms, as well as other legal entities and associations from the fields of hunting, fishing, tourism, forestry, food production and ecology will participate as exhibitors at the event. The layout of the exhibition space is decided by the organizer.

3. Application and participation

Regarding participation in the fair, the exhibitor concludes a Contract with the organizer in the form of Application. The general conditions of presentation are an integral part of the Application.

The deadline for submitting the Application is September 6, 2023.

The organizer confirms the acceptance of the Application form. The application is considered accepted upon confirmation by the organizer and payment of the amount of EUR 80 (VAT excluded) to the organizer's IBAN HR612500091101006386 Addiko Bank d.d. This amount is non-refundable in case of cancellation of the exhibition. The exhibition space will be reserved only upon receipt of payment.

At the end of the deadline for applications and the distribution of the space, a plan of the exhibition space will be submitted. The exhibitor is obliged to exhibit the registered exhibits during the entire duration of the Fair, and responsible personnel must be present at the exhibition area at all times.

Leaving the Fair before closing is not allowed and if it happens, the exhibitor will be invoiced a fee of EUR 120.00 (VAT excluded) for non-compliance with the opening hours of the Fair.

4. Cancellation of participation

If, due to unforeseen circumstances, the exhibitor proposes to the organizer the withdrawal of his Application for Participation no later than September 1st, the organizer will accept the same without additional costs for the exhibitor. If the exhibitor cancels his participation no later than 15 days before the start of the event, the organizer will also accept this, and the exhibitor will be invoiced with 30% of the contracted value of the exhibition space, in the name of compensation for preparation costs. The organizer is not able to accept a later cancellation, so the applicant will be invoiced for the space ordered and the services performed up to that point. If the organizer is forced to temporarily or even for a long time empty one or more exhibition spaces due to force majeure or for some other reason, which is not within his competence, the exhibitor does not have the right of access or cancellation, as well as the setting of some other requests, especially not the right to claim damages from the organizer.

5. Terms of payment

After the deadline for applications has expired, and based on the received Application for exhibiting and the payment in the amount of EUR 100, the organizer will provide the exhibitor with an offer with the specified discount for advance payment, which is payable no later than September 15, 2023. If the exhibitor does not pay the offer within the specified period, he will receive a new offer or an invoice without the mentioned discount, and he is obliged to settle it no later than 5 days prior start of the fair. Also, after the end of the event, the organizer will provide the exhibitor with an invoice for possibly subsequently ordered and performed services, which is payable within 7 days of receipt.

6. Fair services

The exhibitor orders the exhibition space according to the conditions in the price list. The exhibitor can order an unequipped or basic exhibition space and, if necessary, additional equipment. If the exhibitor brings his own equipment, he must also notify the organizer and ask for approval. Every square meter started is counted as 1m2. The organizer arranges the exhibition spaces in accordance with the basic concept. The price of the exhibition space includes a certain number of exhibitor cards, securing the fair space, cleaning the stands and aisles, mediation by the organizer

in matters of promotion and public relations, participation in expert lectures and fair content.

The organizer sets up and equips the exhibition space according to the conditions specified in the application and price list. The stand is installed in the Octanorm system, and the height is 250 cm. The entire surface of the exhibition space is covered with a blue carpet. The inscription on the stand consists of a block of letters 15 cm high, and the length of the inscription is 196 cm and is placed on one side of the stand.

The organizer will hand over the stand and equipment 20 hours before the start of the event. At the beginning of setting up the exhibition space, the exhibitor confirms taking over the stand and is responsible for the stand equipment. Dismantling of the stand can begin after the official end of the event, i.e. on Sunday, October 8. at 17:00 PM. In case of loss of stand materials and equipment, the exhibitor is obliged to compensate for the damage according to the organizer's price list.

The exhibitor cannot assign the exhibition space to another without the consent of the organizer. Complaints about possible defects of the exhibition space must be reported to the organizer before the start of the fair event. Later complaints will not be accepted. If the exhibitor does not take over the ordered area 12 hours before the opening of the event without notifying the organizer of the same, the organizer has the right to dispose of the area in question from that date onwards, charging the exhibitor the entire rent for the exhibition space and all ordered services.

7. Safekeeping and insurance

Simultaneously with the end of the fair, the organizer provides a night security guard at the entrance to the exhibition hall, but exhibitors can additionally order security for their exhibition space and exhibits and secure the exhibition space and exhibits through the organizer or the Insurance Institute. The organizer does not take responsibility for non-executed insurance of exhibits and other property.

8. Exhibitor cards - accreditations and parking tickets

The exhibitor is entitled to 1 free exhibitor card for every 6 m2 of exhibition space. If the corresponding number of cards is not enough, additional cards can be ordered according to the price list. Exhibitor cards are valid from the first day of preparation of the event until the last day of disassembly and must be worn throughout the duration of the fair. Each exhibitor who rents space of at least 6m2 is also entitled to one parking ticket. An exhibitor whose stand is more than 40 m2 can receive two parking tickets upon request. Parking tickets must be presented when entering the exhibitor parking lot and left in a visible place under the windshield.

9. Catalog of exhibitors and advertising

The organizer publishes the Catalog of Fair Exhibitors. Inclusion in the catalog is mandatory. The organizer will enter the basic data from the application form into the catalog. The exhibitor is responsible for the content of entries in the catalog and the content of advertisements, so the organizer does not assume responsibility for possible inaccuracies and incompleteness. Advertising materials must be submitted by September 20, 2023.

10. Sale of goods

In accordance with the applicable laws and regulations, exhibitors can make direct sales at their exhibition stands in accordance with the applicable regulations. In case of non-compliance with the applicable regulations and possible sanctions by the competent authorities, the exhibitors bear the cost themselves and cover any incurred costs for the organizer.

11. Photographing

The organizer has the right to photograph or record the exhibition spaces and use the material for its own needs or for general use.

12. Final provisions

In the event of a dispute between the exhibitor and the organizer, the parties submit to the decision of the competent court in Varaždin.
